APPROVAL OF PURCHASE FROM FDH INFRASTRUCTURE SERVICES, LLC FOR REPAIR, MAINTENANCE AND PAINTING SERVICES TO THE BROADCASTING

It is the recommendation of the administration that the Board of Trustees approve FDH Infrastructure Services, LLC to provide repair, maintenance, and painting services to the broadcasting tower in the amount of \$251,168.

D. Middleton asked about BidNet. J. Foco said that the College now sends all requests for bids through BidNet. It moves bids through the whole United States and can help in expanding and diversifying our vendors. Requests for bid are still sent to our local vendors as well.

Motion passed unanimously.

APPROVAL OF PURCHASE FROM R.L. DEPPMANN CO. FOR COOLING TOWERS (BA5518)

It is the recommendation of the Administration that the Board of Trustees approve the proposal from R.L. Deppmann Co. for the cooling towers for \$716,233.00.

A. Baldwin made a motion to approve the recommendation. B. Handley-Miller seconded the motion.

D. Middleton said that she appreciated the chart that was included with the recommendation. It does a nice job of summarizing the entire project.

Motion passed unanimously.

APPROVAL OF BOARD POLICY 8.017 ACCESS AND ACCEPTABLE USE POLICY (BA5519)

It is the recommendation of the Administration that the Board of Trustees approve the proposed Access and Acceptable Use Policy 8.017.

A. Baldwin made a motion to approve the recommendation. A. Clark seconded the motion.

J. Foco said that the attorney helped in drafting this policy and with revision of the access and acceptable use guidelines. He said that the access and acceptable use guidelines have existed for many years.

Motion passed unanimously.

APPROVAL OF PURCHASE OF FORTIGATE SERVERS AND FIREWALLS FROM NETSOURCE ONE (BA5520) It is the recommendation of the administration that the Board of Trustees approve the purchase as part of the college's lifecycle replacement at a cost of \$134,447.94 from NetSource One.

A. Baldwin made a motion to approve the recommendation. D. Middleton seconded the motion.

Board Chair Thomas called for a second vote. The Board voted unanimously (5-0) to approve the 2024 Regular Meeting Calendar.

The winter semester began on January 6. As of today, 7,864 students are registered. The College projected 67,769 contact hours for the semester and are currently at 112% (75,591 contact hours). Thanks to all faculty and staff for their efforts to reach and surpass our goal.
