STUDENT SUCCESS: STUDENT VOTER REGISTRATION

The Student Success Report entitled "2024 Voter Engagement at Delta College" was presented by Lisa Lawrason, Political Science Professor; Marcie Carter, Manager of Downtown Midland Center; Dorian Phelps, Downtown Saginaw Center Coordinator; and Eliana Muhaxhiri, Delta student.

They discussed the election engagement efforts they coordinated during fall semester. Delta has been actively supporting civic engagement and became a founding member of the Democracy Commitment in 2012. In 2022, Delta had the highest voter registration of any 2-year college in Michigan and a 45% voter turnout rate.
