- M. Nash asked if any equipment purchases were needed to facilitate this program. E. Suniga noted that this was a grant funded project, so the equipment was purchased with grant dollars as well as Perkins funding and the general fund.
- M. Nash asked about the process for approving programs as this was the largest number of programs presented at one time. E. Suniga said that the large quantity was because many of these programs were grant driven resulting in them going through the process at the same time. R. Curry also noted that these programs are the result of faculty working for 1 to 2 years on these proposals.
- B. Handley-Miller asked what colleges we are connecting with for transfer opportunities. E. Suniga said in the business and technology area we have good ties with Northwood University, Davenport University, Central Michigan University and Saginaw Valley State University. Ferris State University was our national partner for the Automotive EV/Hybrid Certificate.
- M. Gavin said that the Health and Wellness Division's proposals are helping with the waitlist, a result of grants and feedback from the students.

This endowed teaching chair project offers 15 weekly videos to demystify math and highlight strategies students can integrate into their study approach to maximize their learning.

The Winter Semester began on January 4. As of today, 8,323 students are registered (2287FT, 6036PT).

We projected 72,225 contact hours for the winter semester and are currently at 111% (79,895 contact hours) of projection.

TRUSTEE COMMENTS

B. Handley-Miller enjoyed the student success presentation and appreciated being able to attend the Possible Dream induction ceremony. She watched the panel discussion on diversity, equity and inclusion that Dr. Gavin was a part of as well as other college presidents. She is proud that we are a leader. Dr. Gavin's message is clear, and we will continue serving our students and when mandates are made then we will make changes.

M. Nash is happy with the College's enrollment numbers as well as the new programs and innovation that were brought forward.

A. Thomas appreciated the presentations and all of the information as she navigates her new role on the Board. She is looking forward to learning more.

A. Baldwin enjoyed the student presentation as it is always her favorite part of the meeting. She thanked everyone for their hard work. She is excited for the Black History Month activities and hopes to attend some of them.

D. Middleton commented on the streamlining and responsiveness to the programs that were eliminated and the new ones that were approved. She wondered if this was a valid concern and if so, what can be done.
