- TREASURER’S REPORT** S. DuFresne said that the Board packet includes financials as of September 30, 2023. She said that in the general fund revenue section our year-to-date State appropriations line item has Zero revenue recorded as of September 30. That is because the College does not start receiving State funding until the month of October.
- In addition, the restricted fund shows revenues under expenditures as of September. This is due to a timing issue as the College records financial aid disbursements on the expenditure side and revenue from the federal disbursements will appear next month on the October financial statements.
- S. DuFresne reminded the Trustees that the auditors will be presenting financial statements for the 22-23 academic year at the November Board meeting.

### **ADMINISTRATIVE REPORTS – STUDENT SUCCESS – DELTA COLLEGE WELDING PROGRAM**

Jim Proctor, Associate Professor; Keith Proctor, Assistant Professor; and Brent Pashak, Associate Professor gave an overview of the welding program and how it aligns with the College's goals of enrollment, retention, completion, and equity.

They discussed their recruiting, retention and completion initiatives, including their new entry-level skills certificate, the ladder approach to the programs, the addition of a collegiate-level Student Technical Solutions chapter and applying for graduation as a course requirement. There were a record 57 program graduates last year. This is a 33% increase from the prior year.

Exemplary welding program graduates, Liam Francis, Katelyn McArdle and Gage Miller, discussed their success at Delta and in their careers.

### **PRESIDENT'S REPORT**

#### **Enrollment Report**

The College projected 71,884 contact hours for the fall semester and is currently at 107.5 percent of that goal, 77,276 contact hours.

#### **Information Sharing**

- Dr. Gavin highlighted several noteworthy events:
  - On September 18, Delta College and MEDC's Talent Action Team announced a major \$500,000-plus expansion to become the national leaders in semiconductor education and training programs. Thanks to the trustees that attended: Alex Clark, Stacey Gannon, Barb Handley-Miller and Mike Rowley. Planning meetings are now underway.
